Tuition includes transportation, meals, snacks, canteen, housing, program materials, camp t-shirt, one-way email service to campers and all activities. Optional expenses include laundry service. Camp is in session Monday through Friday, including Friday, July 3. Tipping of staff is NOT permitted.

**TERMS AND CONDITIONS** (*please read carefully*)

- Parent/guardian agrees that his/her signature below indicates permission for the camper to attend Campus Kids during the 2009 camp season and to participate in all camp activities as listed in the Camp's 2009 brochure (available on the camp website or it can be mailed by request). Parent/guardian understands that some camp activities may require that campers be transported to locations other than the primary camp site.
- Requests to change the weeks of attendance or lengthen a camper's stay can be made only if space is available. There is a \$200 administrative fee if request to shorten the camper's stay is received after February 1, 2009. There is no refund for shortening the camper's stay if request is received after April 1, 2009.
- No financial allowance (refund, credit or other) is made for missed days.
- The Camp reserves the right to dismiss without any refund a camper whose conduct or influence is, in the opinion of the Camp, unsatisfactory or inimical of the best interests of the Camp.
- The Camp is not responsible for loss or damage of any personal belongings of any kind while in transit to or from the Camp, during laundering, or at Camp.
- In case of any emergency the Camp will attempt to contact the parents/guardians. If contact is not made, though, the Camp has the permission of the parents/guardians to assume full responsibility for, and make all decisions concerning, the camper; including, but not limited to, authorizing first aid and emergency medical treatment on the camper. Medical expenses outside of the Camp Health Center are the responsibility of the camper's parents/guardians. If the medical provider does not accept the parents/guardians' medical insurance, then the parents/guardians shall pay the medical provider directly or reimburse the Camp upon receipt of written invoice.
- The camper is not allowed to attend Camp without a fully completed and signed medical form and any other forms as Camp requests to be completed.

- A completed medical form includes a health history completed by parents/guardians within six months of camp attendance and evidence that camper has been examined by a physician within 24 months of camp attendance.
- Parents/guardians hereby consent to the reproduction and use of camper's photograph, image or other reproduction for the purpose of promoting or advertising Campus Kids as well as the general promotion of summer camps through the American Camp Association.
  - Parents/guardians agree that the venue for any legal disputes with the Camp is Morris County, New Jersey.
  - Parent/guardian acknowledges and agrees that his/her signature below represents that he/she has authority to enter into this contract, and assumes responsibility hereunder.

**FEES**

- It is understood that Camp reserves the right not to admit any camper to Camp if all tuition fees are not paid in full prior to April 1, 2009. Camp's admission of any camper shall not be deemed a waiver of any kind.
- All tuition and fees must be paid by April 1, 2009. Any outstanding balances which remain after that date may be assessed interest at the rate of 1.5% per month. If legal action is necessary to collect any outstanding balances, attorney fees and collection costs will be added to the outstanding balances. There is a \$25 charge for any returned checks.
- If notification of cancelled enrollment or reduced length of stay is received by February 1, 2009, Campus Kids will refund all tuition paid. Cancellations or reduced stays received between February 2 and April 1, 2009 will be entitled to a refund of less a \$200 administrative fee. After April 1, 2009 there will be no refunds. Refunds are not given for early withdrawal from camp, *including withdrawal due to camper or parent "homesickness"*.

I understand that until February 1, 2009 a complete refund will be given for cancelled enrollments. Cancellations or reduced length of stay requests received between February 2 and April 1, 2009 will receive a full refund less a \$200 administrative fee. **NO REFUNDS WILL BE MADE AFTER APRIL 1, 2009.**
